- Merge onto I-283 N
- Take I-83 SOUTH RAMP towards HARRISBURG
- Merge onto I-83 S

- ATLANTIC CITY EXWY becomes NJ-42 N
- NJ-42 N becomes I-76 W
- Take the I-676 NORTH exit, exit number 2, towards CAMDEN/B FRANKLIN BR
- Merge onto I-676 N
- Take the I-676 WEST/US-30 WEST exit
- Merge onto VINE ST EXWY
- VINE ST EXWY becomes I-76 W
- Take the I-76 WEST exit on the left towards HARRISBURG/EXITS 23 - 1
- Merge onto I-76 W (Portions toll)
- Take the I-283/PA-283 exit, exit number 247, towards HARRISBURG/HERSHEY Merge onto I-283 N
